Subject to the conditions and exclusions listed below, and on the reverse side, International Comfort Products, LLC (hereinafter referred to as ICP) warrants this product against failures due to defects in material and workmanship for the time periods listed.

**NO HASSLE REPLACEMENT LIMITED WARRANTY –** (Not applicable to all models, see chart below for list of covered models and duration of warranty.) If the compressor, heat exchanger or outdoor/condenser coil fails due to defect during the applicable No Hassle Replacement Limited Warranty time period, a one–time replacement with a comparable ICP unit will be provided. This warranty is in addition to the Limited Heat Exchanger, Limited Compressor, Limited Outdoor / Condenser Coil and Limited Parts Warranties and applies only to the original purchaser. Proof of purchase and installation date will be required. No Hassle Limited Warranty replacements are subject to review and verification by an ICP representative. The remaining balance of the original unit's warranty will be transferred to the replacement unit.

**HEAT EXCHANGER LIMITED WARRANTY –** If the heat exchanger fails due to defect during the applicable warranty period from the date of installation, (see chart below for list of covered models and duration of heat exchanger warranty) ICP will provide a new heat exchanger, without charge for the part itself, or, at ICP's option, allow a credit in the amount of the then factory selling price for a new equivalent heat exchanger toward the retail purchase price of a new ICP product. The Limited Lifetime Heat Exchanger Warranty applies only to the original purchaser. If the purchaser sells the home to a subsequent owner, or if proof of the original purchase cannot be provided, then the limited warranty is only for 20 years from the date of installation.

**COMPRESSOR LIMITED WARRANTY –** If the compressor fails due to defect within five or ten years (depending on model, see chart below) from the date of original installation of the product, (whether or not actual use begins on that date) ICP will provide a new compressor, without charge for the part itself, or, at ICP's option, allow a credit in the amount of the then factory selling price for a new equivalent compressor toward the retail purchase price of a new ICP product.

**OUTDOOR / CONDENSER COIL LIMITED WARRANTY –** If the outdoor / condenser coil fails due to defect within five, seven or ten years (depending on model, see chart below) from the date of original installation of the product, (whether or not actual use begins on that date) ICP will provide a new coil, without charge for the part itself, or, at ICP's sole option, allow a credit in the amount of the then factory selling price for a new equivalent coil toward the retail purchase price of a new ICP product.

**PARTS LIMITED WARRANTY –** If a part fails due to defect within five or seven years (depending on model, see chart below) from the date of original installation of the product (whether or not actual use begins on that date) ICP will provide a new or remanufactured part, at ICP's sole option, to replace any defective part, without charge for the part itself.

**NO LABOR –** None of these warranties cover labor or other costs incurred for diagnosing, repairing, removing, installing, shipping, servicing or handling of either failed parts, or replacement parts, or new units.

## Limited Warranty Certificate

### **Conditions and Exclusions:**

The Limited Warranty only applies if the following conditions are met:

1. The unit must be installed by a licensed or otherwise qualified dealer or contractor.
2. The unit must be installed in accordance with ICP's installation instructions and in compliance with local codes. Improper installation may endanger the occupants of the dwelling.
3. The unit must be operated in accordance with ICP's owner's manual provided with each unit. The product must not be misused.
4. The unit's rating plate must not be removed or defaced.
5. Proof must be supplied that the equipment has been properly maintained over the life of the warranty, i.e., a minimum of once-a-year maintenance.
6. The unit must be installed and located in the continental U.S.A., Alaska, Hawaii, Puerto Rico, or Canada.
7. Warranties apply only to products installed in their original installation location.
8. Defective parts must be returned to the distributor through a servicing dealer for credit.
9. If the installation date cannot be determined it will be deemed to be 30 days after the date of manufacture.
10. Warranties on reverse side apply only to single-family, residential applications. Units installed in commercial or multi-family applications will have a 10-year limited heat exchanger warranty, 5-year compressor limited warranty and a 1-year limited warranty on all other parts.
11. Electric Heater accessories used in residential applications will have a 5-year limited warranty from the date of original installation.
12. All other accessories, including Electric Heaters used in commercial applications, will have a 1-year limited warranty from the date of original installation.

**Limitations of warranties – All implied warranties (and implied conditions in Canada) (including implied warranties or conditions of merchantability and fitness for a particular purpose) are hereby limited in duration to the period for which the limited warranty is given and applies. Some states or provinces do not allow limitations on how long an implied warranty or condition lasts, so this limitation may not apply to you. The expressed warranties made in this warranty are exclusive and may not be altered, enlarged, or changed by any distributor, dealer, or other person, whatsoever.**

1. Normal maintenance as outlined in the installation and servicing instructions or owner's manual including coil cleaning, filter cleaning and/or replacement, and lubrication.
2. Damage or repairs required as a consequence of improper shipping or handling, faulty installation, misapplication, abuse, improper servicing, unauthorized alteration, and/or improper operation.
3. Failure to start due to voltage conditions, blown fuses, open circuit breakers or other damages due to the inadequacy or interruption of electrical service.
4. Damage as a result of floods, winds, fires, lightning, accidents, corrosive environments (except for coastal rated units in coastal environments), rust and wear, or other conditions beyond the control of ICP.
5. Parts not supplied or designated by ICP, or damages resulting from their use.
6. Electricity or fuel costs or increases in electricity or fuel costs from any reason whatsoever including additional or unusual use of supplemental electric heat.
7. **Any special, indirect, or consequential property or commercial damage of any nature whatsoever.** Some states do not allow the exclusion of incidental or consequential damages, so the above limitation may not apply to you.

**This warranty gives you specific legal rights, and you may also have other rights which vary from state to state or province to province.**

Buyer protection plans are available through your installer/dealer. **HELP** (Homeowner's Extended Labor Program) is an optional factory backed extended service agreement that will provide this coverage. This plan provides additional years of service protection and must be purchased and submitted within one year from the date the unit was installed.
